# Call for applications

## For the M8 Alliance prize for the best thesis

#### Art. 1

# Number and type of prize

The M8 Alliance of Academic Health Centers, Universities and National Academies offers **one prize**, for the year 2023, with a grant of € 5.000,00, gross of charges to be paid by the beneficiary, (provided by Roma Sapienza Foundation), addressed to the best postgraduate training (residency) /doctoral dissertation about Health Sciences and Research.

#### Art. 2

# General admission requirements

The call for applications is addressed to early-career candidates who have completed, in one of the Institutions of the M8 Alliance, a formal residency training or a PhD course in health/medical professions, and whose study activity offers a significant contribution to the scientific progress in his/her disciplinary area. This includes both health/medical professionals who completed formal residency training or PhD program during the last year (i.e., 2022) and resident/doctoral students who will complete the degree course within the deadline of this announcement (January 31st, 2024).

#### Art. 3

Application, methods of presentation and qualifications that can be assessed

The deadline for submitting the application is Wednesday, January 31st, 2024 at 23:59 CET.

A pre-selection will be carried out by the candidates' home institutions so that only one candidate per institution can ultimately compete. The selected candidates must apply by registering at the following link <a href="https://forms.gle/qQmXZQpPwipvcVsG8">https://forms.gle/qQmXZQpPwipvcVsG8</a> and completing the online form/process;



candidates must also provide a valid email address for future communications and attach the following documentation to his/her application:

- 1) application form completed and signed (Attachment A, in pdf format to be renamed: Name Surname application);
- 2) copy of a valid identity document (in pdf format to be renamed: Name Surname docidentity);
- 3) curriculum vitae et studiorum (in pdf format to be renamed: Name Surname CV);
- 4) certification of PhD degree with the date of graduation and final mark (in pdf format to be renamed: Name Surname PHD) and/or certification of specialization with the date of graduation and final mark (in pdf format to be renamed: Name Surname.specialization);
- 5) copy of the PhD/specialization thesis (in pdf format to be renamed: Name.Surname\_thesis);
- 6) description/summary of the thesis, including Background, Specific Aims and Methods, Results and Discussion 3-page limit (pdf file to be renamed: Surname\_Name\_thesis-summary)
- 7) any letters of reference or support (in pdf format to be renamed: Name.Surname letter)
- 8) list of most significant publications (in pdf format to be renamed Name Surname publications);

Certifications may also be provided as a self-declaration affidavit (according to art. 47 and art. 19 of D.P.R. n. 445/2000 In Italy) – Annex B.

The attachments must be provided in a PDF format, with a file size limitation of 10 GB. Applications received by any mean other than the one listed above will not be accepted. Requirements must be possessed within the deadline set, under penalty of exclusion from selection.

#### Art. 4

#### Judging Commission and Award Ceremony

All applications received will be unquestionably evaluated by an examining board made up of experts in the field of Health Sciences and Medical Research, nominated by Sapienza Foundation and chaired by Prof. Axel R. Pries, current President of M8 alliance. All applications will be subjected to a rigorous peer-review process and controls on the authenticity of the declarations. The winner will be selected on the basis of the topic of his/her dissertation (i.e., coherent with the topic of this call for applications), the personal contribution to health progress and scientific research, and the curriculum. The selection board will take into account:



- innovation of the topic in current practice within the discipline of the candidate;
- high level of quality in research;
- international exchange, collaborations and partnership opportunities.

The outcome will be communicated to the interested parties by advertising on the website of Rome Sapienza Foundation (provided below).

The winner will be made public during the award ceremony at the WHS in Berlin (October 2024), and he/she will be asked to personally accept the prize during the event, if at all possible. In case of renounce/withdrawal of the candidate ranked as a winner, the prize will be awarded to candidate who, in order, ranked next.

The winners of the competition will be notified to the email address indicated in the registration form and the prize will be paid in a single installment.

# Art. 6 Incompatibility

The scholarship is incompatible with other scholarships / awards, provided by the Sapienza Foundation, received in the same year or in previous years, having the same object.

# Art. 7 Treatment of personal data

The personal data provided by the candidates will be processed exclusively for the purposes of managing the competition procedure.

# Art. 8 Final provisions

For all matters not covered by this announcement, the current italian legislation is applied.
